

From the Superintendent's desk:

Welcome back all students and staff for the 2020-2021 school year! This past spring and summer have been quite an experience to say the least. I am so ready to have students and staff in our building and see all the smiling faces once again. This year's teacher in-service will be held Monday, August 10 and Tuesday, August 11, with our first day of school on Wednesday, August 12. We have a 1:00 p.m. early dismissal time for students on August 12. I have included a couple reminders in my newsletter that will hopefully assist you as we get closer to the first day of school.

I know you may be tired of receiving all the Connect 5 messages over the last 6 months. We have tried very hard to communicate all the rules, expectations, plans etc. for everything taking place at Humphrey Public School. We sent out the "Return to School" plan to all parents and students on Monday, August 3, 2020. I understand the plan had a lot of information but we wanted to make sure we communicated all plan details for the upcoming school year. If you ever have any questions about the plan, please stop by or give me a call as I would be happy to provide additional information to help clarify or answers questions you may have regarding school for grades PK-12.

Mrs. Hanzel is once again hosting ImPact testing sessions on Thursday, August 6 at 8:45 a.m. in the gymnasium for all 7th, 9th, 11th and transfer students participating in athletics. There is no cost to parents for their students to take this test because the school district pays for the testing. We strongly encourage all students who are going to compete in athletics this year to complete the ImPact testing so we can determine the athlete's performance baseline data for the medical personnel should a concussion occur.

On Monday, August 10 at 6:45 p.m., Humphrey Public will host a 7th Grade orientation for students and parents to help prepare students for their first day of school. Ms. Oelsigle and Mr. King will host this meeting.

Due to the COVID-19 health concerns, we are moving to a different format for the grades 7-12 Technology Bootcamp and class registration. We will host two separate opportunities to watch the video, review forms, fees, policies and expectations associated with the 1:1 computer initiative and register your child for classes while following social distancing guidelines. The first night is Monday, August 3 from 4:00-8:00 p.m., the second night is Tuesday, August 4, 2020 from 2:00-6:00 p.m. in the gymnasium. I want to thank the Humphrey Public school board for allowing this initiative to continue. This learning initiative has several goals: to provide our students 24/7 access to learning, prepare students with 21st century skills, amplify learning opportunities for students and enhance communication and collaboration between students, staff and parents/community members.

Bowling is going to be offered as a NSAA sport for the first time this school year and we are hopeful that students will be interested in this sanctioned sport. Bowling is not new to Humphrey Public School, the opportunity to win a NSAA state championship is new. The sport will be cooperative with Lindsay Holy Family in grades 9-12 and will be played during the winter sports season opposite of basketball. All other

grades 7-12 sports will be together with Lindsay Holy Family. We work very hard communicating information with parents and student-athletes to keep them informed on practice locations, leave times and game times. Mrs. Hanzel will put together a Googledoc where ALL practice times/locations, game locations and leave times are posted. He joins us after teaching at Elkhorn Mount Michael for one year and Boone Central for numerous years. Mrs. Zabka joins our food service program; she has a wonderful personality and will be a tremendous asset for our school.

The Free and Reduced Breakfast/Lunch forms will be sent home the first day of school and is also on our school webpage. I encourage all parents to fill this FORM out because should your family qualify for a free/reduced price meal, not only will your children receive a nutritious meal at a free/reduced price, the school district also receives funding based on our free and reduced number of children. This federal program helps fund academic assistance known as Title I for our school. We also receive federal and state reimbursement for every reduced or free meal which helps our school breakfast and lunch program. Please know the free and reduced information is kept confidential and is known by only Michelle Wemhoff & Mr. King. Other forms like the Connect 5 emergency and information form will be sent home with the youngest child in the family the 1st day of school. Please return ALL forms with your child on the second day of school.

2020-2021 Humphrey Public School "Return to School" Plan Phase 4 - August 12, 2020

Humphrey Public Schools Mission Statement:

"We Are Building United, Lifelong Learners That Develop Opportunities And Achieve Goals Successfully"

The purpose of this blueprint is to provide a framework for how Humphrey Public Schools will respond to the COVID-19 pandemic and its impact on the educational program at Humphrey Public during the 2020-2021 school year. The framework is structured using tenets and tiers in order to allow the district to be proactive and responsive to changing public health circumstances. The presence of a formal plan will also support the district in articulating its plan for next fall in a clear, comprehensive, and transparent manner.

Humphrey Public School's goal is to provide the safe return of students, teachers and staff to our school for the 2020-2021 school year. Educators, parents and health directors share the common goal of children returning to school August 12, 2020. We are committed to doing everything we can so all students have the opportunity to safely return to in-person learning. We recognize that children learn best when they are physically at school and present in the classroom. Children get much more than just academics in school. They also learn social and emotional skills at school, get healthy meals, get exercise, mental health support and other services that cannot be easily replicated on-line. Returning to school is very important for the healthy development and well-being of our children, we must pursue re-opening in a way that is safe for ALL students, teachers and staff. We will be listening to public health agencies and local health experts who make

recommendations and decisions based on evidence, data and what is safe for Humphrey Public School. School leaders/administrators, the East Central Health District, other health districts, educators and parents will be at the center of our decisions taking into account the spread of COVID-19 in our community and not what the spread is in communities 60 miles away. We want to share that Humphrey Public School will be starting school on Wednesday, August 12, 2020. We are **REQUIRING** all students and staff to wear a mask for the safety of everyone involved. We have been told countless times by the ECHD and other local health officials if schools are serious about staying in school and not going to a remote environment, we must be proactive and wear masks to mitigate risks of spreading the virus.

Tiered Model and East Central Health Risk Assessment Dial:

Tiered Model: Many of the elements in the plan below have tiered levels of response from the school district. The intended definition of each tier has been provided below; however, the application may vary depending upon guidance from local public health officials or the governor (issued directed health measures). The tiers below correspond with the East Central Health Department Risk Assessment Dial that is updated on a weekly basis. Depending upon public health guidance and other local context, the application of the tiers may be applied more rigorously than the degree of spread indicated in the chart. For example, public health recommendations may compel the use of tier II or III strategies even when no area spread exists. Likewise, the school district may choose to apply tier II actions in one tenet area when the conditions and public health recommendations will only result in the use of tier I practices. In this way, the real intent behind the tiered model below is to proactively outline the progressively rigorous actions the district may take as circumstances change throughout the pandemic.

Tenet: Screening

A list of important School Reopening information will be emailed home and given to staff and parents which includes the following common symptoms of COVID-19: fever of 100.4 Fahrenheit or greater; cough; shortness of breath or difficulty breathing; chills (or repeated shaking with chills); unusual muscle pain; headache; sore throat; loss of taste or smell. Signage will be at school entrances and throughout school which includes the common symptoms of COVID-19 and appropriate steps to take when these symptoms are present. Any student who reports to staff or would be exhibiting any COVID-19 symptoms will be referred to the office and they will have their temperature taken and be further assessed as deemed appropriate by the school's trained staff. Professional development will be provided to all staff regarding the recognition of COVID-19 symptoms. |

School Exclusion:

Students and employees will be excluded from school if they test positive for COVID-19 or are currently exhibiting symptoms and are waiting for COVID-19 test results.

Testing Positive-Symptomatic:

Persons who experience symptoms and have been tested for COVID-19 may return to school if the following conditions are met:

- The individual no longer has a fever (without the use of medicine that reduces fevers) for 72 hours; and
- Other symptoms have improved (for example, when your cough or shortness of breath have improved); and
- At least 10 calendar days have passed since symptoms first appeared.
- Written release by their health care provider.

Tested Positive-Asymptomatic:

Persons who have not had symptoms but tested positive for COVID-19 may return when they are approved to do so in writing by their health care provider.

Tested Negative - COVID-19:

Persons who have been excluded due to COVID-19 symptoms and have tested negative may return to school if the following conditions are met:

- The individual no longer has a fever (without the use of medicine that reduces fevers) for 24 hours; and
- Other symptoms have improved (for example, when your cough or shortness of breath have improved).

Medical Inquiries:

- If a parent tells the district/school that a student is ill, the district/school will ask the parent whether the student is exhibiting any symptoms of COVID-19.
- If an employee calls in sick or appears ill, the district/school can inquire as to whether the employee is experiencing any COVID-19 symptoms.
- School Administration or school designee will ask parents to inform the school in writing from their health care provider on any COVID-19 testing
 with children that attend Humphrey Public.

Note: Even without symptoms, if a student or employee has recently had contact with a person with a suspected or confirmed case of COVID-19, has someone in their home being tested for COVID-19, or has recently traveled from somewhere considered to be a "hot spot" by the CDC, the district/school may exclude the student or employee from the school building and recommend that they self-quarantine for 14 calendar days. Decisions in these circumstances will be made in collaboration with public health officials and will <u>vary based upon the specific circumstances</u>.

Screening:

- Cones may be set up outside the entrance doorway for students to stand by maintaining 6 feet social distance.
- Students will enter the school building through the following doors. (Signs will be posted on Doors)
 - PK Students Enter through the east door by PK / SPED room.
 - Grades 7-12 Enter through the north glass main entrance doors.
 - Grades K-6 Enter through the south playground entrance.
 - Bus Riders Enter through the south glass main entrance doors. (Unload one bus at a time.)

Students will be called in one by one to have their temperature checked with the infrared thermometer and temperatures documented.

- If the temperature is above 99.5, we will take it again 1-2 minutes later. If the temperature is decreasing and under ideal temperatures, allow entry. If it is still above 99.5, they will be asked to go home. Retake no more than two times.
- If the temperature is 100.4 or higher, the student will be sent home, parents will be contacted and encouraged to consult their family physician based on guidelines from the East Central Health District.
- All responses and temperature within range will be documented.

Students will be asked three essential questions.

- Have you knowingly been in contact with Covid-19?
- Have you or anyone in your family been ill/sick recently?
- Have you traveled outside the United States in the last 14 days?
- o If the answer is YES to contact or travel:
 - The student athlete will be instructed to return home and the parents will be contacted. The student will not be allowed to return for 14 days.
 - Parents will be encouraged to contact their health department for directions and follow up with their coach/sponsor.
- Students will also be asked if they are experiencing any of the following symptoms:

- Cough
- Shortness of breath or difficulty breathing
- Muscle pain not due to physical activity
- Sore throat
- New loss of taste or smell
- New headache, or consistent headache
- If the answer is YES to any of the symptoms
 - The parents will be asked to contact their healthcare provider. The student may not be allowed to return until after being released from the healthcare provider.
 - Parents will be encouraged to contact their health department for directions and follow up with their coach/sponsor.
- Siblings of the symptomatic student will follow the same recommendations as symptomatic students.
- o Staff members MUST enter using the main entrance (southeast door) and be screened.
 - If staff arrives prior to 7:45 a.m., staff will screen themselves and document results.
 - Staff kids and being in the building prior to 7:45 a.m. and after school (want to avoid mixing of lower elementary, upper elementary, and 7-12 students.)
- Screen all students during 8th period. (If possible to have a second person helping larger class sizes). By temperature checking all students 8th periods, this will help in determining if students are safe to ride the bus home as well as to participate in after school activities. We are communicating with both St. Francis and Lindsay Holy Family Schools to be as consistent as possible with our plans to keep kids safe both in-school and during after school activities.
- After the screening process is completed, students will be asked to wash their hands. Hand sanitizer stations will also be available

Grades 7-12 Remote Learning Plan (2020-2021 School Year)

If we decide to go to a Remote learning environment, Humphrey Public School will follow this Remote Learning Plan. Students in Grades 7-12 would follow our current 2020-2021 academic class schedule at their scheduled times.

Core Classes (English, Math, Science, and Social Studies)

- Students will meet "live" during their scheduled time on Monday, Wednesday, and Friday.
- The teachers would be live via ZOOM during their scheduled class time and students would be required to attend via ZOOM.
- On Tuesday and Thursday, core class teachers would be available to ZOOM for assistance during their class time.
- No additional assignments on Tuesday and Thursday.

Elective Classes

- Students will meet "live" during their scheduled time on **Tuesday and Thursday**.
- The teachers would be live via ZOOM during their scheduled class time, and students would be required to attend via ZOOM.
- On Monday, Wednesday, and Friday, elective class teachers would be available to ZOOM for assistance during their class time.
- No additional assignments on Monday, Wednesday, and Friday.

Attendance

• If a student is not in attendance for your class while you are hosting a virtual class, they will be considered absent. If your class does not meet virtually, you will mark the students "present" or "in attendance."

Grading

- For all classes, grading would be done on a normal grading scale as if we were in session at school. If a worksheet has 100 problems and a student misses 14 problems, that student would receive an 86%. If another student does the same worksheet and misses 2, that student would earn a 98%.
- Students not completing assignments would have a zero in the grade book for that assignment until it is completed.
 - O Students who turn in assignments late (all assignments would be due at midnight the Sunday after it is assigned) would receive the same "penalty" for the late grade in every class. Each week the assignment is late, 10 percent will be deducted from the final grade. For example, if a worksheet has 100 problems, and the student gets all of the problems correct, but the student turned the assignment in late, that student would receive a 90% for a grade. If another student turns in the same assignment late and gets 75 of the problems right, that student would receive a 65% for a grade.

Presentation

- All teachers will be using Google Classroom as their online platform. There will be 20-25 minutes (20 preferrable) to give direct instruction / lecture and then the other 20-25 minutes would be work time/interaction with the students.
- The teacher's delivery of instruction can vary. Teachers may break it into two 10-minute sections or maybe three 5-minute sections and give interaction / work time in between. It may look different for each teacher for each day.

Re-opening Tips and Information for Parents for our 1st day of School - Wednesday, August 12, 2020

- What's New:
 - o Doors will open for students to enter at 7:45 a.m.
 - Water fountains are shut off, however the hydration stations will be available. Students will get a water bottle the first day of school or they may bring their own clear bottle.
 - Face coverings are required. Acceptable face coverings include cloth masks, surgical masks, gaiters. Bandanas or handkerchiefs are not permitted. All masks must follow dress code guidelines for appropriateness. When social distancing can be done safely, students will be provided mask breaks.
 - If treats are brought in for birthday parties etc., individual pre-packaged treats are highly recommended.
 - Sanitizing tables with sanitizer are placed throughout the school building and available for staff/students to use at their convenience.

Transportation:

- Bus route--The family transportation plan set forth at the beginning of the school year will not accommodate daily bus change requests.
 - Example: We will not transport non-bus route students to birthday parties. We will not transport students to PRE in Tranov when that is not their traditional route.
- Activity transportation--All students, coaches, and sponsors will wear masks while being transported when social distancing is not possible.
- Students will be temperature checked with infrared thermometers and screened before entering the school bus. Students will not be allowed on the bus with a fever so please make sure students are healthy. In the event your child is running a temperature and not allowed on the school bus, there needs to be someone at home old enough to care for the child.

Screening Process:

- o Parents are asked to temperature check and screen children for symptoms at home before sending children to school.
- Students will be temperature checked and screened before getting on the school bus.
- Designated doors for student entrance will be:
 - Preschool = East door
 - K-6 = South door by playground equipment
 - 7-12 = Main entrance
- o Once students are screened, students will go directly to their classroom.
- Upon entry, only the student will be allowed in school. Child will be screened at the door. Parents will not be allowed in the building.
- All parents and visitors will be temperature checked and screened upon entering school.
- Upon exit during school hours or after school, parents will meet their child outside the building using the doors they came into the building.

• When a Child is Sick:

• Parents are highly encouraged to see a health care provider when a child's fever is 100.4 or higher and/or multiple COVID-19 symptoms are present.

Food Service:

o Breakfast and lunch will continue to be in the cafeteria with minor seating modifications.

Elementary Specials:

o During physical activities, masks will not be required.
